**NEW! 360 / Spherical Photography**



New in 2024 and available now. What is 360 / Spherical Photography? This is most commonly used in real estate for property virtual tours. We have adapted this technique to apply to indoor and outdoor scenes, from buildings to vehicles. We are among the first to introduce this for investigative purposes in Colorado, and of a handful nationwide. The process captures from multiple rooms to the full building, or vehicle interior and exterior. Very cost-effective, capture time takes minutes for a room or vehicle, and about an hour for every 1,000 square feet – all depending on the scene. Post-processing time varies depending on the scene and client needs.

There are unique advantages to 360 / Spherical Photography over video:

- No video panning, loss of detail, fast forward / rewind, or background noise – the full area is captured in the general scans. Detailed photos can be pulled from the scans as requested.
- Measurements can be taken from the model, and are reasonably accurate for general purposes (not forensic purposes – see our 3D LiDAR Scanning).
- The client can “walk-through” the scene, zoom in and out, and inspect items in the model – without piecing together individual photographs. Following forensic protocols – specific evidence is separately individually photographed.
- Files are viewed securely online, with archived and exported files in common CAD .XYZ format or 3D mesh file in OBJ format with texture files, as well as floor plan views in JPG or PDF.
- Floor plan schematics and measurements are available from the image capture files.
- All 360 / Spherical Photography assignments include: 1) Assignment Report and Photograph Log; and 2) Requested images and export files.
