Think FARO and Total Stations – on a cost-effect, accurate, and mobile scale. We are in the process of completing this specialized training, which will fully complement our Forensic Photography, 360 / Spherical Photography, and Drone Photography. Models can be exported for use in CAD and other programs – including Cloud Compare, FARO, Leico and others for forensic / crime scene programs, and provide accurate measurements.

After extensive training and hours, Dean is certified by Recon3D in this process as of February 2024.

Using mobile LiDAR technology and Recon3D, the scans provide accurate measurements and full 3D imaging. Time and cost effective, capture time takes less than 30 minutes for smaller areas to larger areas, and individual items of evidence – including vehicle interiors and exteriors with accuracy. Reconstructed scenes can be captured before and after setup for full details and perspective. Post-processing time varies depending on the scene, evidence, and client needs.

For civil and criminal litigation, we can inspect and scan small to medium indoor and outdoor areas or evidence onsite and document details. These 3D scans can be further examined by a Subject Matter Expert, including ourselves as appropriate, for and to document evidence and measurements in an immersive model. Advantages include:

- The client can "walk-around" the scene, building, vehicle, intersection, etc., and zoom in and out, and inspect areas with captured images. Following forensic protocols – specific evidence is separately individually photographed.
- All Photography and Videography assignments include: 1) Assignment Report and Photography / Video Log; 2) Original Files and Duplicate Files Renamed to the Assignment; and 3) Contact Sheet of All Photographs with Name, Date & Time Stamp. Scene Diagrams are completed as appropriate.


